SECTION 1: <u>AUTHORITY</u> This Local Law is enacted pursuant to the authority of Article Nine-A of the General Municipal Law of the State of New York.

SECTION 2: <u>DEFINITIONS</u> The words and terms used in this Local Law shall have the same meaning as such words and terms have under the provisions of the General Municipal Law of the State of New York and more particularly Article Nine-A thereof.

SECTION 3: GAMES OF CHANCE AUTHORIZED; RESTRICTIONS Games of chance may be conducted in the Town by an authorized organization, after obtaining a license therefor, in accordance with the provisions, requirements, and limitations of Article Nine-A of the General Municipal Law, the rules and regulations of the New York State Racing and Wagering Board and this Local Law.

The conduct of games of chance on Sundays is authorized, except as otherwise restricted in Article Nine-A of the General Municipal Law.

SECTION 4: The powers and duties set forth in subdivision one of Section 194 of the General Municipal Law shall be exercised by the Chief Law Enforcement Officer of the County of Franklin.

SECTION 5: EFFECTIVE DATE This Local Law shall take effect immediately upon filing with the Secretary of State after approval thereof by the voters of the Town voting thereon at a general election held on November 6th, 1990 pursuant to the provisions of the Municipal Home Rule Law.
